**SECTION 708A(5) CLEANSING NOTICE**

Overland Resources Limited (ASX:OVR, **Overland** or the **Company**) today issued 49,116,062 shares at an issue price of \$0.011 per share (the **Securities**) to institutional and sophisticated investors to raise \$540,277 pursuant to the Tranche 2 of the Placement announced on 5 March 2018 and approved by shareholders on 26 April 2018. The Company intends to use the funds to continue exploration at the Yandal East Gold Project and for general working capital purposes.

**Notice Under Section 708A(5)(e)**
